

EDELNet+ PhD Training Programme

Summer Schools LLM/LLB (May-July 2024)

Call for Applications

In this 2024 call, the combined intensive program is organized at UNED by Professors from the Faculty of Law in coordination with four other international universities: FernUniversität Hagen, (Hagen, Germany); OU OpenUniversitat Netherlands; University of Wroclaw (Poland), Open University (UK) and UNED. Its purpose is transversal training in legal knowledge and skills. Its titled: "Bachelor Summer School (LLB) and Phd Summer School (LLM)". This courses are supported by the Erasmus +, Acción Clave 1 (KA1) Programm at UNED (https://www2.uned.es/bici/curso2023-2024/24012916/16-1.htm#11.-

The training will take place from May 2024 to the beginning of July 2024, with the first part of the Moodle Course taking place in online mode on the FernUniverstät platform (Hagen), and the second part in person at the Faculty of Law of the UNED (Humanities School building, predictably). Each university will select and contributes its group of students in a quota of 6 students, depending on the total number of final participants and the funds allocated in each University. Therefore, those who apply must do so at their own University of origin. At UNED we have predisposed a number of six admitted for selection according to the quota that is finally assigned.

Some funds will be available, for the selected students, as partial grant to attend the course for those who don't live in Madrid, like some trip expenses and affordable residence in-city, thru the abovementioned KA1 action program.

During the seminar students will work in cross-national groups of Law students, LLB (Bachelor) and LLM (Master/PhD.) from seven European countries and at least six Universities to get acquainted with the theory and practice of a series of methods of great relevance to legal knowledge. The course begins with a theoretical input organized in online lectures, readings and exercises thru the online course (Hagen moodle course). After this, students will be assigned to a cross-European team of



students and will be requested to fulfill group tasks geared towards the practical application of the methods learned. Finally, regrouped in different teams participants will be asked to fulfill a final assignment that will be evaluated by a team of more than 20 experienced professors, lecturers and researchers from the partner universities.

During the in-person week, seminar lectures, formation-skill sessions and moot exercises will take place by international groups. Both seminars guarantee feedback from and interaction with fellow students and instructors throughout the program.

The Course is held entirely in English, in an international environment, which offers the value of developing the student's academic and linguistic skills, while creating an international environment that is sustainable over time. The experience provided by carrying out these Courses over many editions has allowed us to achieve an optimal academic and organizational level, in constant academic improvement, as evidenced by the quality evaluations carried out.

REQUIREMENTS:

This training is aimed at Bachelor's (LLB) and Doctoral (LLM) students in disciplines in the area of Legal Sciences (Law), who meet a series of requirements:

- To be enrolled in LLB level, the student <u>must</u> be in the last years of the Degree (3rd or 4th Year) in Law, and be enrolled in 2024, on an UNED Master's Degree or be during the the Doctoral Thesis elaboration at UNED, for the LLM level.
- All students admitted students <u>must</u> complete the two phases of the course: the online and the in-person.
- At least B2 English level, proved by any official English certificate system is required.

Applications will be considered <u>until 26th February 2024</u>, as final deadline (selected students will be announced at the beginning of march 2024).

Applications must include a short CV and an official English Certificate.
